**2. COMPOSITION**

Chemical Characterisation:

Laminate sachet containing a disposable tissue impregnated with a solution containing 100% ISOPROPYL

**3. HAZARDS IDENTIFICATION**

Potential hazard effects:

- Product is FLAMMABLE. Packaging is combustible paper solid
- Do not use near flames or sources of ignition
- May cause eye irritation

**4. FIRST AID MEASURES**

Ingestion (mouth):

- Rinse mouth with water several times.
- Consult a physician and show this Safety Data Sheet
- Do not induce vomiting

Skin:

- If contact is prolonged or excessive, wash hands with water
- Get medical attention if complaint persists.

Ingestion (lungs):

- Avoid repeated inhalation.
- Get fresh air and rest.
- Get medical attention if complaint persists

Eyes:

- In case of contact flush eyes immediately with copious amounts of water

**6. ACCIDENTAL RELEASE MEASURES**

- Lift soak up inert material and put in a secure container marked 'FLAMMABLE' for disposal

Handling:
